Edward F. Sporl started his career as a draftsman for New Orleans architect Thomas Sully in the early 1900s. He became a prolific designer of commercial and residential structures in New Orleans and the gulf south region. Of note are homes he designed for Gentilly Terrace, for New Orleans developers Bacchich and DeMontluzin.

## PROVENANCE

Drawings were generated and preserved by Sporl over the course of his career. At the time of his death they were still in the office of his last partner, Murvan “Scotty” Maxwell. With Maxwell’s consent, Sporl’s son Edward F. Sporl, Jr. removed a majority of the drawings in 1984 and gave them to SEAA. Additional items were received with the donation of records from the office of Maxwell and LeBreton in 1988.
