Records of the office of New Orleans architect Moise H. Goldstein (1882-1972), and records of successor offices, as noted in the following chronology.

Moise Herbert Goldstein was born in New Orleans. He graduated from Tulane University (B.E. 1902), and the Massachusetts Institute of Technology (M.S. 1905). He briefly partnered with New Orleans architect, H. Jordan Mackenzie (1870-1956) under the name Mackenzie and Goldstein. He then worked with C. Collins Diboll, Sr. (1869-1936) and Allison Owen, Sr. (1869-1951) under Diboll, Owen, and Goldstein. He then went on to establish his own practice. Buildings of note designed by him include the American Bank Building, Temple Sinai (with Emile Weil), Emlah Court Apartments, and Feibleman Department Store, all in New Orleans. He designed early buildings for Dillard University's campus, and designed Dinwiddie Hall and the first Howard-Tilton Memorial Library for Tulane University.

In 1947, Goldstein made Frederick D. Parham and F. Monroe Labouisse partners with him, changing the name of the firm to Goldstein, Parham, and Labouisse. The firm became prolific designing many mid-20<sup>th</sup> century buildings. Important commissions included New Orleans City Hall, the New Orleans Public Library, and Moisant Airport (now Louis Armstrong Airport). The firm dissolved in 1962, and Goldstein worked briefly with his son, architect Louis A. Goldstein.

## PROVENANCE

After the breakup of Goldstein, Parham, and Labouisse in 1962, the records of the firm were divided. Parham and Labouisse took some material, chiefly items pertaining to projects with which they had been especially involved. Moise Goldstein kept the remainder. He practiced a short time longer with his son, Louis Goldstein, but then retired. Louis continued a little longer on his own, but in 1965 moved to Michigan. Before leaving, Louis donated the bulk of the material to the original Manuscripts Division of the Tulane library, along with some of his own records. All of this material was transferred to SEAA in 1980. A few items were donated by Goldstein's widow, who also gave some things to Dillard University. Further donations came from Milton G.

Scheurermann, Jr., formerly a member of the Goldstein, Parham, and Labouisse office. In the late 1980s, Louis Goldstein gave a small group of items found in a house owned by his father in Pass Christian, Mississippi.
